## NOTICE


The candidates who have qualified the stage of Document Verification for the posts of Forester, Deputy Forester, Wildlife Forester and Forest Guard as listed in Annexure I,II,III and IV respectively are provisionally shortlisted for the Physical Standard Test (PST) and Physical Efficiency Test (PET) which shall be conducted on 12<sup>th</sup> of June 2024 at **Airport Road Barchay Colony, Kurbathang Kargil**. The candidates may note:

1. They shall report for the Physical Standard Test (PST) and Physical Efficiency Test (PET) at sharp **6:00 AM** at the scheduled venue and date along with valid Identity Proof (Aadhar Card/PAN Card/Passport/Driving License/Voter ID Card, etc.). No candidate will be allowed after the cut-off timing.
2. Standards laid down by the Indenting Departments for these posts are:

Physical Standard Test	Height: Male Minimum 162 cm Female 152 cm
Physical Efficiency Test	25 KMs walk to be completed within 04 hours

3. Passing PST and PET is mandatory and the same will be of qualifying nature. No marks will be awarded to these tests.
4. Candidates who do not have minimum height as prescribed by the Indenting Departments shall not be considered for the PET and shall be treated as disqualified.
5. Candidates appearing for the PST/PET shall produce Medical Fitness Certificate issued by the Chief Medical Officer, at the time of test as per the format prescribed in Annexure "V".
6. The female candidates who are pregnant shall not be allowed for the PET and may be declared temporarily unfit until the confinement is over. The vacancy against which the pregnant women candidates can be selected, if in merit for selection, would be kept reserved for them. They would be re-examined and their PET would be conducted later after the pregnancy is over, subject to the production of Medical Fitness Certificate from the Chief Medical Officer and would be considered for selection if they qualify PST/PET.
7. Candidates who have been shortlisted for more than one type of post from amongst the above-mentioned posts shall submit the preference as per the format given in Annexure "VI" at the time of PST/PET. The above scheduled Physical Test will apply to all above posts wherever they have been shortlisted.
8. If at any stage of recruitment/joining/appointment, it is found that the information provided by any candidate is incorrect/incomplete/false or not in conformity with the eligibility criteria as prescribed in the advertisement notice or found ineligible under the relevant Recruitment Rules of these posts, his/her candidature/appointment will be cancelled without assigning any reason.

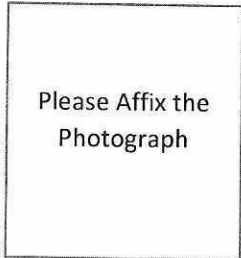
