Whereas, vide this office notification No. KSSRB/Notice/2024/78-86 dated. 23.04.2024, fresh document verification of the candidates for the post of Work Supervisor as per merit were conducted at the office of District Employment and Counselling Centre Kargil from **01.05.2024** to **02.05.2024**.

Whereas, in view of representations received from the candidates who missed the document verification held from <u>01.05.2024</u> to <u>02.05.2024</u>, as last and final opportunity, final round of document verification was conducted from <u>13.05.2024</u> to <u>14.05.2024</u> as per the already notified schedule.

Whereas, the applicant (<u>Mrs. Kaneez Fatima, Appl. No KSSRB22016086, Roll No. 307518</u>) did not attend the Document Verification process on the above-mentioned dates and thereafter approached the LAHDC-KSSRB for one more chance for document verification which was denied on grounds that multiple/sufficient chances were already given to the candidate(s) for document verification.

Therefore, in view of the Hon'ble CAT Bench Srinagar directions, it is notified for information of the petitioner that her document verification for the post of Work Supervisor-I will be conducted on **17.08.2024** (Saturday) through the respective Board as intimated vide this office notice No. KSSRB/Notice/2024/78-86 dated. 23.04.2024.
