Document Verification of Mohd Abass (Appl. No. KSSRB22048585 Roll

No.308333) for the post of Electrician L-2.

Reference: Decision No. 01 of LAHDC-KSSRB of the Board Meeting held on

15.02.2025.

<u>ORDER</u>

Whereas, as per requisitions received from the indenting departments, the LAHDC-KSSRB had advertised 04 posts (2-UR, 2-ST) vide Advertisement Notice No. 02 of 2022 dated 02.12.2022 for recruitment as Electrician L-2 in the Health & Medical Education Department, UT Ladakh;

Whereas, a common written examination was conducted for these posts requiring Matric (10th pass) as minimum qualification on 28th May, 2023;

Whereas, based on the merit secured in the written examination, 12 candidates were provisionally shortlisted for Document Verification which was conducted through a Board constituted vide order No. KSSRB/DV-Boards/2023/289-95 dated. 20.07.2023;

Whereas, a Technical Committee was constituted vide order No. KSSRB/ DV-Boards/Posts/ 2023/705-709 dated. 05.12.2023 to ascertain the eligibility or otherwise of the candidates based on the Technical/Experience certificates submitted by them during the Document Verification for these posts in terms of recruitment rules notified by the concerned Indenting Departments as mentioned in the advertisement notice:

Whereas, 06 candidates were declared eligible for the posts of Electrician L-2 by the Technical Committee;

Whereas, based on their merit of OMR based written examination and as per the report of the Technical Committee, candidates were provisionally selected for the 04 posts (UR-02, ST-02) as per the category-wise break-up received from the departments with two (02) candidates in the waiting list and selection notice for the post of Electrician L2 of Health and Medical Education Department was issued vide No. KSSRB/Pro-Select-List/2023/838-52 dated 13.01.2024;

Whereas, one candidate namely Mohd Abass (Appl. No. KSSRB22048585, Roll No.308333) with higher merit than the selectees could not selected for the post of Electrician L2, since as per records he had not attended the document verification through the respective DV Board for the said post.

Whereas, he approached the Hon'ble CAT with the grievances (re-verification of documents as projected in his representations) and the Hon'ble Court has passed the order dated 20.05.2024. The operative content of the order is as under:

"In the meanwhile, it is provided that the respondents will bring before this Court the marks obtained by the petitioner in pursuance to his, having applied post of Electrician (L2) vide Advertisement No. 02 of 2022 dated. 02.12.2022, as well as record of the document verification, if submitted by the petitioner.

This order is purely provisional and subject to scrutiny and verification of eligibility, essential qualifications, category etc. by the appointing authority.

The respondents is directed to redress the grievances of the petitioner as projected in the appended representations".

Whereas, in compliance of the Hon'ble CAT directions, the required documents were submitted to the Legal Officer to the Deputy Commissioner/CEO, LAHDC, Kargil vide this office letter No. LAHDC-KSSRB/Court-Case/2024/933 dated. 14.08.2024 for its further submission to the Hon'ble CAT.

Whereas, in the meantime the Indenting Department, Health and Medical Education, UT Ladakh vide letter No. Pr. Secy/H&ME/UTL/2021/1083-87 dated. 07.01.2025, requested this office for operation of waiting list due to cancellation of offer of appointment of already selected candidates as none of the candidates had joined the said post within the stipulated time period.

Whereas, this necessitated fresh Document Verification which was notified vide Notice No. KSSRB/Notice/2024-25/1711-1719 and the same was conducted on 15.02.2025 for filling of these vacancies.

Whereas, the said candidate namely Mohd Abass (Appl. No. KSSRB22048585, Roll No.308333) approached LAHDC-KSSRB with the request that he may be provided another chance for Document Verification and subsequent selection through Waiting List for L2 Electrician post as he had missed the DV on the scheduled date 03.08.2023 due to some confusion since on the same day his DV for another post Water Khalasi/Khalasi/Lineman/Assistant Motorman /Blacksmith was scheduled in the morning while as in the evening, DV for Electrician-L2 Post was scheduled and he had explored the possibility of conducting the DV for both posts at the same time and discussed it with the then DV Board Officer.

Whereas, an LAHDC-KSSRB Board meeting was convened on 15.02.2025 with the matter also on the agenda wherein the then DV Board Officer was also present and the matter was discussed.

Whereas, it appeared that due to some confusion the candidate had missed the DV for Electrician L2 on 03.08.2023 in the afternoon shift as there seemed to be no conclusive reason

for him not to appear in the DV in afternoon shift as he had appeared for document verification in the morning shift for the post of Water Khalasi/Khalasi/Lineman/Assistant Motorman/Blacksmith on the same day.

Whereas, accordingly the Board decided that the candidate may be provided another chance for DV for the said post and will be considered for waiting list as per merit.

Therefore, in view of the Hon'ble CAT Bench Srinagar directions and as decided by the Board, it is notified for information of the petitioner that his document verification for the post of Electrician L-2 will be conducted on **25.03.2025** (Tuesday) 02:00 PM at District Employment & Counselling Centre, LAHDC, Bagh-i-Khumeni Kargil, through the Board No. 3 constituted vide this office Order No: KSSRB/DV-Board/202-25/1704-1710 dated:20.02.2025.

The candidate shall present himself personally before the said DV Board on the said venue along with the necessary documents as notified vide this office Notices No: KSSRB/Notice/2023/230-38 dated: 08.07.2023 and No: KSSRB/Notice/2023/280-88 dated: 20.07.2023.
